City bank accounts have a total of \$6,832,589.68 in restricted funds, reserve funds, and usable monies.

<u>City Events Discussion</u> – Doug Potts and John Doyle discussed the difference between a city-sanctioned event (funded by the city) and a even held within the city (in-kind support is provided by city staff in the parks, fire and police force).

<u>Staff Training:</u> Michele Brown discussed the upcoming management coaching that will be provided to all supervisors within the city during the week of March 11 – 15, 2024.
